**At-Promise House Parent Contract**

I, \_\_\_\_\_, parent of \_\_\_\_\_ am choosing to enroll my child in the At-Promise House a school-within-a-school for the Central Union High School District. I understand that this participation is voluntary and I may ask that my child be returned to the comprehensive high school campus under certain conditions. I understand that my child is credit deficient and recognize that immediate, intensive intervention is needed in order to provide my child the best opportunity of graduating on time in June of 2024.

**As the parent I understand that my child will be expected to:**

1. attend school 90% of the days provided unless they are sick, have a doctor’s appointment, or on a school sponsored function, or have a family emergency.
2. maintain a minimum GPA of 2.0 while in the program.
3. attend summer school, afterschool, and other educational opportunities provided in order to recover deficient credits.
4. participate in counseling sessions, academic advising, and graduation plans weekly with either the counselor or homeroom teacher/teacher.

**As the parent I understand that I will be expected to:**

1. communicate weekly with my child’s homeroom teacher via telephone, Zoom/Google Meet, or in person.
2. ensure that my child attends school 90% of the time, and if, they can not attend I will notify the attendance specialist.
3. Check the Aeries portal weekly to view my child’s grades, attendance, and other important information, but if I don’t have access I will keep close contact with my child’s homeroom teacher.

**As the parent I understand that my child will be afforded:**

1. weekly meetings with their homeroom teacher.
2. daily social emotional learning/counseling during advisory.
3. time after school to complete homework, conduct credit recovery, or meet with peers to study.
4. opportunity to take an elective course and physical education course on the comprehensive high school campus.
5. the opportunity to start the year with a GPA refresh.
